NOTE 3: Eligible Costs are costs incurred through: (A) integrating an electric heat pump with an existing or new natural gas furnace or boiler including the purchase and installation of a heat exchanger in the existing ductwork of a natural gas forced air furnace, a heat exchanger in the existing hydronic system of a propane or natural gas boiler, controls that ensure the electric heat pump operates when the outdoor ambient temperature is greater than two degrees Celsius, or changes to the existing natural gas heating system that are required to integrate with an electric heat pump; or (B) the purchase and installation of a natural gas or propane furnace or boiler that is integrated with an electric heat pump; or (C) the purchase and installation of a heat/energy recovery ventilator. See section 3.5 of the *Residential Dual-Fuel Space Heating and H/ERV Program Terms and Conditions* for more details.

NOTE 4: The Rebate payable is limited as follows:

- per Dual-Fuel Space Heating System using an existing natural gas or propane furnace or boiler: to the lesser of: (A) 100% of the Eligible Cost; and (B) \$2,500.
- per Dual-Fuel Space Heating System that includes the installation of a new natural gas or propane furnace or boiler: to the lesser of: (A) 100% of the Eligible Cost; and (B) \$3,500 or \$5,000 if awarded rebate from CleanBC is less than \$9,000.
- per Heat/Energy Recovery Ventilator: to the lesser of (A) 80% of the Eligible Cost; and (B) \$1,600.

NOTE 5: The Low Carbon Energy (LCE) Bonus of an additional \$200 is available to Eligible Participants who receive a Rebate and elect to subscribe to PNG's Low Carbon Energy program and receive at least 10 percent of their deliveries from PNG in the form of Biomethane and continue such subscription for a minimum period of one year. The LCE Bonus will be automatically issued on the one-year anniversary of the date on which the Eligible Participant subscribed to the LCE program. The maximum Rebate payable in any calendar year period is \$8,000. See section 4 of the *Residential Dual-Fuel Space Heating and H/ERV Program Terms and Conditions* for more details.
